We at [INSERT ORG NAME] along with Catalyst for Payment Reform are calling on all self-insured employers to act by:

- 1. Securing ownership of their claims and clinical #data by including a core requirement in requests for proposal documents.
- 2. Eliminating #gag clauses in their TPA and vendor contracts, which limit access to and use of data and therefore prevent purchasers from fulfilling their #ERISA Plan #fiduciary obligations.
- 3. Setting parameters around how long it takes to acquire data for use by themselves and by their business associates.
